HOSPITALITY – Mike and Fran Fahsel will be unveiling the Delaware Regional Hospitality Suite (room 814) beginning this evening at around 11:45, and will be open Friday and Saturday as well. This is in addition to the hospitality treats available outside the main ballroom following the evening session.

PRIZES - Prizes can be found in the Coat Room on the hotel's ground level, around the corner from the main ballroom. Jess and Lois Stuart and their committee members will have the room open daily beginning on Thursday, one hour before each afternoon and evening session. It will also be open for an hour after the Sunday Swiss Team. Prizes are awarded for the highest score each direction in all sections of match point play. There are not separate prizes for A, B and C strata in stratified sections, just a prize for the top section score. When two sections are scored together on a combined top, both 1st in “A” and 2nd in “A” will receive section top prizes. There are no prizes for overall event winners, except that the Knockout and Swiss Team winners for each flight or stratum will be given section top prizes since there are no separate sections. The prizes include bridge books, golf balls, Lenox lead crystal, photo albums, men's wallets, ladies' purses, scarves and other items.
