PARKING

Parking in the Evening

The DoubleTree parking fee is \$3.00 for vehicles entering after 5:00 p.m. No vouchers will be given.

During the Day, Thursday - Friday

When the DoubleTree garage is full drivers will be directed to the Courthouse garage, on the same side of King Street, one-half block past the DoubleTree.

The special tournament daily charge will be \$5.00 all day at either the hotel or Courthouse lot.

The driver must come to the Parking Table for a coupon. THE COUPONS ARE DIFFERENT FOR EACH PARKING GARAGE.

To pay at the DoubleTree garage, the parking ticket is inserted in the machine at the exit gate and the regular \$8.00 fee is displayed. Then the driver inserts the coupon and the display shows \$5.00 owed.

Parking at the Courthouse

At the Courthouse there are two payment machines at the walking entrance. The driver first inserts the parking ticket, the machine shows the regular fee (\$10.00), then the driver inserts the coupon and the fee shown is reduced to \$5.00. This \$5.00 has to be paid in cash or with a credit card. **At the exit gates, only credit cards can be used for payment. THE COURTHOUSE GARAGE WILL BE CLOSED AT MIDNIGHT EACH NIGHT!!!.**

Saturday Parking

The cost for parking at the hotel with a coupon will be \$3.00 for the day. Without the coupon the driver will have to pay the regular \$8.00 parking fee at the exit gate. **No validation coupons will be given for parking at the Courthouse garage on Saturday.**

Sunday Parking

Parking is free at the hotel garage on Sunday. The courthouse garage is closed.

Doubletree Overnight Guests

Overnight hotel guests have the parking fee on their hotel bill and tournament vouchers are not valid.

The Downtown Wilmington Bike Patrol

The Downtown Wilmington Bike Patrol will be available to escort you from the Doubletree hotel back to the Courthouse garage lot. Information on this service is available outside the main ballroom.

PRIZES

Prizes can be found In the coat room on the hotel's ground level, around the corner from the main ballroom. Jess and Lois Stuart and their committee members will open the room daily starting Wednesday, about forty five minutes before each afternoon and evening session. It will also be open for an hour after the Sunday Swiss Team. Prizes are awarded for the highest score each direction in all sections of match point play. There are not separate prizes for A, B and C strata in stratified sections, just a prize for the top section score. When two sections are scored together on a combined top, both first in A and second in A will receive section top prizes. There are no prizes for overall event winners, except that the Knockout and Swiss Team winners for each flight or stratum will be given section top prizes since there are no separate sections. The prizes include bridge books, golf balls and an assortment of household items.
